Action to approve Order No. 081619-7 of the Bexar County Emergency Services District No. 1 levying the ad valorem taxes for the 2019 Tax Year at a rate of \$ 0.093625 per \$ 100 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 1 to provide revenue for maintenance and operation needs for the 2020 fiscal year; and at a rate of \$0.0 per \$ 100 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency District No.1 to provide revenue for Bexar County Emergency District No.1 to provide revenue for debt service needs for the 2020 fiscal year.
