

**Bexar County  
Emergency Services District No. 1  
Meeting Minutes  
June 10, 2025  
5:30 P.M.**

**The Bexar County Emergency Services District No. 1 conducted a meeting on June 10, 2025 at the Bexar County Emergency Services District No. 1 office located at 8275 FM 78, Suite 2, Converse, Texas 78109 and the following was discussed;**

1. Commissioner Ortiz called the Bexar County Emergency Services District No. 1 Meeting to Order at 5:30 P.M. and established a quorum with Commissioners' George, Galindo and Murphy.
2. Citizens Forum (3-minute time limit per individual). Chris Herrera spoke about a Commissioners Training Class and invited the Board to attend.
3. Approval of the March 11, 2025 Special Meeting, April 4, 2025 Special Meeting, April 8, 2025 Regular Meeting, May 14, 2025 Special Meeting, May 20, 2025 Regular Meeting and May 27, 2025 Special Meeting. Commissioner Galindo made a motion to approve the meetings from April 4, April 8, May 14, May 20 and May 27 with the exception of March 11, 2025 which had already been approved on April 8, 2025. Commissioner George seconded the motion. Motion carried by a 4/0 vote.

  - b. Events. Plans are in motion for the 3<sup>rd</sup> annual Summer Camp for the month of July.
5. Action to sign an agreement with HdL Companies to provide its services to the District. Commissioner Murphy made a motion to sign an agreement with HdL Companies to provide its services to the District. Commissioner Galindo seconded the motion. Motion carried by a 4/0 vote.
6. Update on potential property for the District's office. Commissioner Ortiz has been in touch Mr. Willburn and by the next meeting will have more information on the property.
7. Possible update by Commissioner Ortiz related to the interlocal agreement with the City of Converse. Commissioners Ortiz and Galindo plan on meeting with the Chief and City Manager in the near future to continue negotiating over the Interlocal Agreement.
8. **Financial Reports.**
  - a. Review of the Financial Reports for the District. The Board reviewed the Reports.
  - b. Approval to pay the bills for the District. Commissioner George made a motion to approve paying the bills for the District. Commissioner Murphy seconded the motion.

Motion carried by a 4/0 vote.
